This is with reference to the proposal submitted by PACE Institute of Technology & Sciences, NH-16, Near Valluramma Temple, Ongole-523 272 (Andhra Pradesh) affiliated to Jawaharlal Nehru Technological University, Kakinada- 533 003, Andhra Pradesh under the UGC Scheme for Autonomous Colleges.

On the basis of the compliance report submitted by the college and the recommendations of the Standing Committee, the Commission at its meeting held on 09.07.2018 has decided to grant autonomous status to PACE Institute of Technology & Sciences, NH-16, Near Valluramma Temple, Ongole-523 272 (Andhra Pradesh) affiliated to Jawaharlal Nehru Technological University, Kakinada- 533 003, Andhra Pradesh for a period of ten years w.e.f. 2018-2019 to 2027-2028.

The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.


